## Appendix C – District Councillor Report

**New Grounds Maintenance Contract** - Following a successful tender exercise, Stratford-on-Avon District Council has awarded a new contract to carry out grounds maintenance across the District from 1 April 2024.

- The five-year contract has been awarded to Continental Landscapes Ltd, with the option to extend for up to a further five years.
- The contract covers all District Council owned and maintained parks and open spaces covering grassed areas, floral beds, shrub beds/herbaceous beds, hedge maintenance, tree watering, weed control and removal.
- The contract also includes park cleansing, park furniture and play equipment maintenance, the maintenance of the paddling pool at the Recreation Ground, together with lifebuoys maintenance along the River Avon in Stratford-upon-Avon and winter gritting.
- The new contract includes Key Performance Indicators and Annual Contract Targets to drive service improvements, as well as introducing new features such as 'No Mow May' on Warwickshire County Council Highway verges.
- Another change is that herbicides will not be applied to any grassed areas, floral beds, shrub beds/herbaceous beds or hedges, as part of the weed control, it will be limited to hard surfaces and spot treatments of invasive weeds and wildflower areas only.
- Continental Landscapes Ltd will also be using HVO fuel, from second generation biofuel and a RTFO accredited supplier, for their vehicles together with electric equipment.

**Community Safety** - Stratford-on-Avon District Council is carrying out a 7-week Public Space Protection Order (PSPO) consultation in Stratford-upon-Avon town centre. A Public Space Protection Order (PSPO) is a control measure created by the 2014 Anti-Social Behaviour, Crime and Policing Act. The orders deal with specific nuisances or problems in a defined area that are 'detrimental to the community's quality of life' and are designed to tackle anti-social behaviour in public places.

The District Council is consulting on the following condition:

• Anti-social behaviour anywhere within 'Stratford-upon-Avon Town Centre' when consuming or possessing alcohol.

The behaviour which the District Council is looking to prohibit has been identified as detrimental, persistent and unreasonable to the area. It will not stop members of the public from drinking in public. It will, however, allow the police officers and police community support officers additional powers to deal with those who are drinking or possessing alcohol and engaging in anti-social behaviour. Residents are invited to comment via SDC's website and the consultation runs until 8 May.

**HS2** - We have been notified of a road closure on the A423 on 20 and 21 April as follows: "We will be working along the highway verge of the A423 near Southam. Given the type of work required, and that this is an A-road with fast traffic, we will need to close the road.

- The A423 Banbury Road, between Ladbroke and Southam, will be closed Saturday 20 April and Sunday
- 21 April 2024, from 8am to 6pm.
  - Access to properties and businesses within the closure area will be provided
- We have timed this work to avoid other road closures in the area, and to avoid weekday peak traffic."

## Appendix D – County Councillor Report

## **Division issues**

Harbury Crossroads: Work on this long time project is finally planned to be completed by 15th April and handed back to WCC for the road to be resurfaced. The resurfacing work will involve night time closures for the week commencing at 19.00hrs and reopening at 06:00 hrs between 15th April - Sat 20th April 2024 (5 nights). After this there may be some verge side works continuing but the junction will be fully operational.

This will deliver a significant improvement in road safety which began over ten years ago when I was asked to present Peter Kostiak's petition to the WCC full Council.

HS2: I have had three meetings with HS2 to discuss progress but also non-compliance with the HS2 Code of Practice by main contractors. The closure of A425 was announced after shortly after a meeting with our MP and Councillors to discuss plans, during which no mention was made of the intended closure. We complained at the most recent MP meeting about the pointlessness of such "consultation" if HS2 is unable to give us forewarning of such closures and requested HS2 to treat our communities with more respect. We thought the point was made. Five days after that most recent meeting HS2 announced the closure of the Fosse between 29th April and 3rd May. No mention was made.

I will be referring this behaviour to the Construction Commissioner who appears to be the only person to whom HS2 listens. The works between Wormleighton, Priors Hardwick and Lower Boddington remain significantly behind the

proposed timetable started in July 23 with the closure of the Wormleighton Road scheduled for late autumn 23 still to commence.

Flooding: Following the significant rainfall over the last few months, I have been working with and had a number of on-site meetings with Jeoffery Hobday and the WCC Flood Risk Management Team. A number of actions have been agreed to reduce flooding in two villages. Separately I have reported the actions of the developers of Compton Locks for pumping water onto Station Road to both Jeoffery Hobday and to Orbit. Both are investigating as this is not acceptable.

Secondary schools admissions: On secondary School Offer Day, 1st March, over 95% of all Warwickshire residents will be offered one of their top three choices of secondary school. Unfortunately, it is not always possible to offer every child a place at one of their preferred schools. Parental choice is an important part of the admissions process, and whilst there can be several reasons why a child won't have an offer for one of their preferred schools, in many cases it is because parents have chosen not to apply for their local school.

ASB and neighbour disputes in affordable housing: I received a call from a BI resident about ASB towards his granddaughter living in affordable housing in the village, She is a vulnerable person. I have been working with our District Councillors, the affordable housing provider and Council officers to resolve this difficult issue. The affordable housing provider's response is to seek the rehousing of their tenant, possibly away from her care network, not the perpetrator. It seems wrong that a perpetrator of concerning levels of ASB is more difficult to move than a victim. Nigel and I have raised significant concerns with housing and ASB officers and the affordable housing company.

Ufton Waste tip and green waste IVC facility – planning extension: Following significant concerns from residents about the smells and flies seemingly coming from the IVC facility at Ufton, the Planning Officer, who I have been corresponding with over the matter, offered to attend a PC meeting in Ufton and he reassured residents that if the extension of the site operation for 14 years is granted, there will be specific and enforceable conditions included over the nuisance of flies and smell from the site. This is achievable through the use of new technology that can measure the nuisance effect of flies and smells although the control mechanism have been used many times elsewhere in the past.

WCC Cllrs Discretionary fund: Please don't forget opportunities to improve certain aspects of the WCC Highway Network whilst I still have funding road related schemes in my delegated highways budget.
