Appendix C – District Councillor Report

Fiftieth Annual Council Meeting of Stratford on Avon District Council: The Annual Meeting of Stratford District Council takes place on Wednesday 15 May. This Annual Meeting is also an opportunity to celebrate the fiftieth annual council meeting of Stratford on Avon District Council. 330 Councillors have served the Council in the past fifty years and past Councillors are invited to join the Council at their Annual Meeting to celebrate this milestone.

Community Safety – CCTV: Stratford-on-Avon District Council's Cabinet has approved the direct award of UK Shared Prosperity Fund (SPF) grant funding of £200,000 to carry out vital work to upgrade CCTV infrastructure, software and equipment.

UK Shared Prosperity Fund (UKSPF) is a three-year funding deal. Funding is to be spent across the three themes of: communities and place, business support and people and skills. One of the specific objectives within the Shared Prosperity Fund Prospectus is Built & Landscaped Environment to 'design out crime' (E5) intervention. Stratford-on-Avon District Council will utilise the Shared Prosperity funding for four key initiatives:

- CCTV data storage upgrade
- Five new CCTV Camera Replacements
- Stratford-upon-Avon Recreation Ground Wireless System Upgrade
- Eight new re-deployable camera upgrades

Stratford-on-Avon District Council operates a 24-hour CCTV control room which covers nine towns and parishes across the District. Working in partnership with Warwickshire Police and other key agencies, the team deal with over 14,000 incidents per year. Not all incidents relate to criminal activity, CCTV has played a key role in supporting vulnerable people with welfare related incidents, environmental management by monitoring flooding, road traffic accidents and flagging incidents to partner agencies to allow them to deal with issues more effectively.

Public consultation shows that residents feel that crime is a principal area they wish to see more investment from authorities. The Stratford Citizens Panel 2020 revealed that residents wished to see the greatest increases in spending relating to CCTV and crime reduction in the District.

The function of the CCTV control room contributes significantly to the prevention and detection of crime which is a statutory duty of Stratford District Council under the Crime and Disorder Act 1998. This upgrade also aligns with the District Council's new Council Plan 2023-27 objectives which aims to reduce crime and anti-social behaviour.

GP services in Upper Lighthorne: The work to provide a GP practice at the new village at upper Lighthorne near Gaydon has proceeded to a new phase. NHS Coventry and Warwickshire Integrated Care Board (ICB) has awarded St Wulfstan Surgery the contract to deliver GP services to Upper Lighthorne following a successful tender process. Upper Lighthorne was identified as an area needing additional primary care provision due to the new housing development, which will see 3,000 new homes built over a 10-year period – potentially increasing the local population by more than 7,000.

St Wulfstan is rated Outstanding by the CQC and was rated the tenth best practice in England, and first for practices with over 10,000 patients, in the 2023 GP Patient Survey and have experience of opening a branch surgery. The new branch practice is set to open in summer 2027 as part of the new village centre. The new premises are part of a joint development with Stratford District Council.

The need for a such a facility at Upper Lighthorne has been highlighted by the work carried out by members of the 24 Parishes in the area and demonstrates the need for community infrastructure to go hand-in-hand with housing development.

No Mow May: Stratford-on-Avon District Council will be taking part in No Mow May this year, following the new grounds maintenance contract and the Ecological Emergency Notice of Motion passed at Full Council on 22 April. No Mow May is one of the actions which will preserve and enhance biodiversity within Stratford-on-Avon District. This

aligns with our climate emergency declared in 2019 and with one of the District Council's Council Plan objectives to increase and protect green spaces which positively affect nature recovery.

No Mow May has multiple positive impacts for biodiversity. Reduced mowing allows different plant species to grow, which provides food sources for pollinators and other animals. Longer grass also provides wildlife with shelter. No Mow May also reduces pollution, increases carbon sequestration, and reduces emissions by reducing fuel use.

It is a contractual requirement for No Mow May to be carried out on highway verges, on non-rural roads with a speed limit of 40mph or less. Some road junctions will continue to be cut to maintain sight lines and not restrict the visibility of road users.

No Mow May forms part of a wider agenda to enhance biodiversity which is being delivered by Stratford-on-Avon District Council. Other measures that have been delivered include tree planting, the creation of wildflower meadows on Council owned land and the declaration and ecological enhancement of a new Local Nature Reserve.

Open Space Supplementary Planning Document: At Full Council on Monday 22 April, formally adopted its revised Open Space Supplementary Planning Document following a public consultation, where all Public Open Space as part of new developments will now be adopted by either the local Town/Parish Council or by the District Council. For some time both here and nationally there are concerns raised by residents about:

• Charges levied by the private management companies appointed by the developers to maintain the public open space which are not always made transparent at the time of purchase, can change every year and are unlimited.

• The quality of the maintenance work carried out.

Also, where a Parish or Town Council decides not to take ownership of public open space, the District Council would generally take ownership of the land, with responsibility for ongoing maintenance. The option of passing maintenance responsibilities onto private management companies would no longer be included in Section 106 agreements.

This updated Supplementary Planning Document (SPD) clarifies public open space created as part of new development should be offered for adoption to (in order):

a) Parish Council or Town Council

b) Stratford-on-Avon District Council

The changes provide the District Council with the basis to fulfil its decision to secure high quality open space as part of new development, and where appropriate, acquire and maintain public open spaces.

Appendix D – County Councillor Report

Division issues

Harbury Crossroads: The delay to the works has been extremely frustrating. However, National Grid are on site today and until Thursday to connect the lighting columns

All WCC's and the subcontractor works are essentially complete and the traffic lights have been calibrated. As note above the remaining piece of work is the connection of the street lights, illuminating the junction, to the mains supply. All the ducting is in place but National Gris formerly Western Power Distribution, although given four months notice have not met the deadlines agreed with them to connect the lighting stands.

For Highway safety reasons, the new traffic lights cannot be switched on until the street lights are operational, so the

temporary lights have to stay. As they do not have the technology to allow filtering, the new multiple lane layout cannot be used.

The Traffic management team have therefore had to continue with the existing safety approved layout until National Grid complete the connections. This is now anticipated to start next Monday.

I have personally written to the project manager of National Grid and been on site with WCC's own site supervisor over the weekend. There are no options to remove the traffic cone layout. WCC officers are extremely unhappy to have been let down by National Grid. But it is a matter beyond their control.

HS2: I have met meeting with the HS2 Construction Commissioner, Sir Mark Worthington, appointed by the Transport Secretary on Wednesday to discuss and complain out the behaviour of both local track contractors BBV and EKFB about their continuing and avoidable disruptions to local residents and businesses.

The works between Wormleighton, Priors Hardwick and Lower Boddington remains significantly behind the proposed timetable started in July 23 with the closure of the Wormleighton Road scheduled for late autumn 23 still to commence.

The closure of the A423 at Southam, over a whole weekend to remove what turned out to be 30 metres of hedgerow was unnecessary.

These points were raised along with many others.

Primary schools admissions: Primary School Offer Data As of 9 April 2024, the data is as follows:

There were a small number of families who applied late for Reception and Junior Schools along with families changing their previous applications.

For children who have not received an offer at any of their chosen schools, the local authority has a legal duty to ensure the child is offered a school place to start in September 2024. This year, there are 54 reception children and 4 junior children in this situation. They have been made an offer at the school that is closest to their home address and has places left after all the on-time applications have been considered.

ASB and neighbour disputes in affordable housing: I, with your District Councillors are continuing to work on this challenging matter.

Ufton Waste tip and green waste IVC facility – planning extension: The planning application for this sitie is still being considered. The planning officer has made a detailed site visit to assess the source of local residents' concerns. This is achievable through the use of new technology that can measure the nuisance effect of flies and smells although the control mechanism have been used many times elsewhere in the past.

Speed limits on Station Road: The Traffic Regulation Order have been drafted for the new speed limits have now been drafted and will shortly be going out for statutory consultation. I have not been given a specific date but I have spoken to the Director of the Service and requested that every effort be made to ensure this is carried out ASAP.

Bus stops: These was not funded in the S106 agreement for the Compton Locks site and there is limited funding within WCC for additional stops. So I am pursuing other avenues including whether new bus stops can be funded from my discretionary highways budget.

WCC Cllrs Discretionary fund: Applications for this opens today.

Please don't forget opportunities to improve certain aspects of the WCC Highway Network whilst I still have funding for road related schemes in my delegated highways budget.
